Stallion Owner and Mare Owner, for and in consideration of the Stud Fee listed above, do hereby agree as follows:

**Breeding Rights:** Mare Owner is purchasing the right to breed the above referenced Mare to Stallion during the Breeding Season. Mare may be bred by artificial insemination with shipped semen. Mare Owner is responsible for any and all Additional Costs of collection and shipping of the semen which shall be paid directly to New Bolton Center by Mare Owner. Mare Owner acknowledges the Collection Days, however Stallion Owner will use best efforts to cooperate with collection as required.

**Substitution of Mare:** This Contract is specific to Mare, named above, and no substitutions of Mare shall be permitted without prior written approval of Stallion Owner.

**One Foal:** This contract is for the production of one live foal. While Mare Owner is free to use any breeding method desired, Mare Owner covenants that only one foal will be registered as a result of the rights granted in this contract. Specifically, if Mare Owner, through the production of twins or as a result of embryo transfers, produces more than one live foal, then Stallion Owner will not be required to cooperate in the registration of more than one foal. At the complete discretion of Stallion Owner, more than one foal may be registered if Mare Owner pays an additional Stud Fee.

**Live Foal:** A foal shall be considered "live" if it stands and nurses without assistance for at least forty-eight (48) hours after the time of birth. If a foal is born and is not considered "live" under the definition herein, Mare Owner is required to provide Stallion Owner with a report from a veterinarian indicating a reason that the foal did not survive.

**Live Foal Guarantee:** If Mare fails to conceive or produce a Live Foal resulting from breeding attempts during this Breeding Season, then Mare Owner shall have the right to have the Mare rebred during Next Year's Breeding Season. If Stallion is available to breed during the next year's Breeding Season and Stallion Owner is willing and able to supply shipped semen, and a live foal is not produced, Stallion Owner shall be released from any and all responsibilities arising from this Contract and Mare Owner shall not be entitled to a refund of one half the Stud Fee. If Stallion is unavailable for breeding during the Next Year's Breeding Season and Stallion Owner is unable to ship frozen semen then Mare Owner shall be entitled to a full refund of the Stud Fee, however there shall be no refund of any Additional Costs at any time, for any reason. **STALLION OWNER MUST BE NOTIFIED WITHIN SEVEN (7) DAYS AFTER THE END OF THE BREEDING SEASON, THE LOSS OF A FETUS, OR THE DEATH OF A FOAL THAT MARE OWNER IS EXERCISING THE RIGHT TO USE THE LIVE FOAL GUARANTEE PROVISION OF THIS CONTRACT. IF SUCH NOTICE IS NOT PROVIDED, IN WRITING, THEN MARE OWNER HAS FORFEITED ANY RIGHTS RESULTING FROM THIS GUARANTEE.**

**Sale or Death of Stallion :** If Stallion is sold before Mare Owner exercises all of the

rights created in this Contract, Stallion Owner agrees that Stallion shall be sold subject to being legally bound by the terms of this Contract. If Stallion is sold and transported outside continental United States or if Stallion dies before fulfilling the obligations of this Contract and Stallion Owner is unable to provide frozen semen, then Stallion Owner has the right to terminate this Contract and refund any portion of the Stud Fee that has been paid. **IF STALLION OWNER COLLECTS AND STORES FROZEN SEMEN FROM STALLION MARE OWNER AGREES THAT STALLION OWNER MAY USE PREVIOUSLY COLLECTED SEMEN TO SATISFY ITS OBLIGATIONS HEREUNDER.**

This Contract constitutes the entire agreement between the parties and may not be modified except in writing, signed by both parties. This Contract is not transferable without the written consent of Stallion Owner.
